WEST INDIAN OCEAN

Madagascar, Mauritius, Comoros, Seychelles, Réunion Island.

Vulnerability assessment of the 5 islands states, and participatory design of the regional climate change adaptation strategy.

WEST AFRICA

Senegal. Sustainable development strategy of the semi-arid Ferlo area, using large-scale participatory approaches involving regional and local public authorities together with livestock breeders and their representatives, and women association in charge of milk processing.

MEDITERRANEAN SEA

Lebanon. capacity strengthening and re-engineering of the public water service (water and sanitation). Design and implementation of the Water sector training centre for public and private operators within the sector.

Tunisia. Design of the integrated coastal zone management plan using participatory approaches involving forest operators, citizens and marine operators, local authorities of the North-west coast in Tunisia.

Corsica. coordinating the dialogue with the 94 local authorities (urban and rural cities) to prevent the coast zone from urbanisation (areas under regulation). Managing participatory approaches to design local urban plans for towns taking in account environmental issues and agricultural development priorities for the territory.
